I hereby recognize that I am becoming part of a team. While a member of DDST I know that my actions reflect onto my team members.

I then resolve to do the following:

- 1. I will endeavor to be polite and kind to others. Rudeness to others reflects badly on my team members.
- 2. I will not take illegal drugs, and in fact can never even have them on my person. (My bag, or pockets for instance.) Not only are they bad for my own body, they reflect badly on my team members. If caught and arrested the people of Douglas County, and in fact Nevada, if not the entire West Coast will think that all Douglas swim athletes are involved in my illegal activities. I know what illegal drugs are, they are any drug not given to me by a doctor or my parent.
- 3. I will not take performance enhancing drugs. (Steroids for example). Not only do they cause many medical problems, like liver cancer, they are not sanctioned for use by any sport; amateur or professional.
